# Pre-Flight Briefing: Spring 2026 North Central Section Meeting Hosted by the All-Ohio 99s

Mark your calendars for an unforgettable weekend! The All-Ohio Chapter of the Ninety-Nines is excited to host the Spring 2026 North Central Section Meeting in Batavia, Ohio from March 27-29, 2026. #### Inbound for Landing: Clermont County (169) or Cincinnati, OH (KCVG)

For those flying in, the host airport is Clermont County Airport (I69), where landing and tie-down fees will be waived for the event. On the other hand, if you're flying commercially, Cincinnati/Northern Kentucky International Airport (KCVG) is located just 30 minutes from the hotel.

### NORTH CENTRAL SECTION MEMBERSHIP REPORT

Nat King Cole's ballad reminds us of how the seasons and our lives change. So, too, does our membership. We see spikes in new members and renewals several times a year...at Sun'n'Fun, WAI and primarily at EAA-AirVenture. Many continue their membership for years thereafter. Others do not renew after their first year.....in spite of notification the member is on "Standby" when the first month lapses and on "Hold" the second month. Then the member's name is withdrawn from our Directory, no longer a 99.

Review of the past 5 years of NCS membership reveal that we lose an average of 9% of our members within 14 months of joining. Yes - NCS membership continues to grow....but what would the total be if we did not lose once enthusiastic members? Why do new members not renew? What happened to her excitement of being a 99? Why did she join? What were her aviation goals? How did she engage with Chapter members? Was she invited to share car or plane rides to 99s events? Did she expect an easy route to a scholarship? Did she have a 99 mentor? Did she know about the resources on The 99s website? Was she introduced to a sister 99 who lived nearby? What small Chapter tasks was she asked to help with in that first year? What strengths could she have contributed

to the group? What did we do [or not do] in that first year help our new member begin to learn the value of being a 99? What could current members have done to help her feel welcome?

Our chapters are not the same without these lost members and we miss their enthusiasm & our opporunities to help them achieve their aviation dreams. How can we change this pattern?

It's Scholarship Time!

**First Wings applications** have now been posted on the Ninety-Nines website in the Member Section. One notable change: *Mentors will now need to write a letter of recommendation* for the applicant.

**AE Memorial Scholarship**: Applications are now posted on the website in the Member Section. THERE HAVE BEEN SEVERAL CHANGES! Here are some of them: The General Requirements and Instructions were updated 08/2025, so please read them carefully. The application itself has also been updated. Instead of boxes for letters of recommendation and essay, applicants will attach a full size page for each as PDFs within the application package. Essay, personal recommendation, and the chapter recommendation each require a separate page.

Chapter AE chairs--can be chapter chair OR a chapter officer if no AE Chair. This is to allow for more options (for example, if the AE chair wants to apply and needs a recommendation).

Please make sure applicants read the Instructions *before*, *during*, *and after* completing their application. 1st time-for an overview of what's expected (including documents and due dates!), 2nd time-while filling out the application, and 3rd time-to make sure something wasn't omitted/misinterpreted. Also, AE Chairs/Chapter Chairs--make sure you are familiar with the updated instructions/requirements so that you are able to advise your applicant(s).

# INTENT TO SEEK ELECTION PACKET Election Year 2026

All candidates for International elective positions must file an "Intent to Seek Election" form according to the instructions appearing with the form. Candidates must meet the qualifications as outlined in the Bylaws and Standing Rules. Each person considering running for the Board should be familiar with The Ninety-Nines, Inc. governing documents, (Articles of Incorporation, Bylaws, Standing Rules, SOP's and BOP's) are located in the library in the Members Only Section of the Ninety-Nines website.

All members of the International Board of Directors (IBOD) must attend three Board of Directors (IBOD) meetings per year. The spring and fall IBOD meetings are held at the preferred and default location of our Headquarters, Oklahoma City; the annual meeting is held at the site of the Annual International Conference and requires the BOD members to arrive one or two days early for pre-conference, finance, and other business meetings.

The annual budget allows a stipend for the BOD Secretary, Treasurer, and four Directors, currently set at \$3,500 per year. This is provided to help offset travel and hotel expenses to the three mandatory Board meetings. The current stipend for VP is \$5,000 and President is \$10,000 to reflect the extra travel expenses in their roles.

The IBOD shall be composed of the four (4) officers, and four (4) directors. The immediate past president shall be an ex-officio voting member of the IBOD.

INTERNATIONAL OFFICERS - The elected officers shall be a president, vice-president, secretary, and treasurer.

INTERNATIONAL DIRECTORS - The non-officers of the BOD consist of four Directors, with two Directors elected in odd-years and two Directors in even-years.

THE IMMEDIATE PAST PRESIDENT serves on the Board for one term after her presidency. They take part as a full Board member, with the same responsibilities as other Directors, including attending Board meetings. The Past President helps ensure smooth leadership transitions and organizational stability.

Serving as a member of the Board requires substantial time and constant communication with other members and with the membership in general. Each member of the Board must possess excellent communication skills and should have regular access to computer(s) and the internet. A Board member is expected to write all reports to other Board members after representing the President at a Section meeting or other meetings she may be required to attend. Additionally, each Director acts as a liaison with one or more International Committees of The Ninety-Nines and is expected to attend as many Section meetings as possible.

A term for an officer or director shall be two years, and all officers and directors shall serve no more than two consecutive terms in the same office. The responsibilities of each elective position available this year are at the end of the packet. Please read and understand them prior to submitting an "Intent to Seek Election" form. If you have any questions, contact an individual who has or is serving in the position you seek or contact the nominating committee.

Check them carefully before submitting the "Intent Form.".

To be considered for an elective position all candidates must prepare and submit the following:

- 1. "Intent to Seek Election" form. You may not seek or state endorsements by Chapters, Sections, or the International Board of Directors.
- 2. A position statement of no more than 250 words. The position statement will appear in the *Ninety-Nines* magazine.
- 3. A resume of not more than 2 pages.
- 4. Submit 1 recent head & shoulders digital photograph in high resolution (at least 300 dpi.)

You are to submit all documents (1-4 above) electronically via email to the Nominating Committee (nominating@ninety-nines.org).

The DEADLINE FOR RECEPTION is December 31, 2025. If sent by mail rather than electronically, you must submit all documents to Headquarters and to each of the five members of the Nominating Committee as follows:

#### **ELECTED POSITION REQUIREMENTS**

THE PRESIDENT represents The Ninety- Nines at meetings and public appearances and must be able to communicate verbally. She formulates matters of policy and must be willing to spend time away from home on the business of the organization. She is given a yearly expense budget which she may use to help on support services, travel costs or other items consistent with the reimbursement policy, found in the members only section of the web site. She is an ex-official member of all International Committees except the Nominating Committee. She is responsible for conducting the Annual Business Meeting and other such meetings as may be necessary. She strives to connect with each Section during her term, whether by attending a meeting in person, joining virtually, or through other outreach, to support members and strengthen relationships across the organization. She should maintain good communications with the overseas sections and members and, if possible, should meet with overseas members in their sections or countries. The President also writes a column for each issue of the 99s Magazine and answers voluminous amounts of correspondence. After her presidency, she must also serve on the Board of Directors as the Immediate Past President for one-two year term as an experienced advisor and mentor to the current President.

**THE VICE PRESIDENT** serves as a member of the Finance Committee and serves in the place of the President whenever necessary. She serves as the primary liaison with Section governors and serves on any of the International Committees at the request of the President. When requested to do so, she represents the President, and, therefore, The Ninety-Nines. She understudies the President, and they work in close harmony on various long-range goals and objectives of the organization. She assists other officers in their duties and aids in the harmonious operations of the Board.

**THE SECRETARY** is responsible for recording and transcribing off all minutes of the corporate Board meetings in the approved format and forwarding them within thirty days of any meeting. She is responsible for the recording and transcription of the full and condensed minutes of the Annual Business Meeting. She is required to handle correspondence at the request of the President, and she must stay in constant communication with International Committees and Headquarters staff. She should have access to the necessary computer equipment and should possess good writing skills.

THE TREASURER must be able to analyze and produce corporate financial statements and be proficient at analyzing computer financial information. She chairs the Finance Committee and prepares a proposed budget for the spring Board meeting. She is responsible for compiling all financial information and providing the Board with accurate financial statements on a regular basis. She prepares and/or presents the following items for the Annual Meeting: Adopted Budget, Budget Comparison, Headquarters Balance Sheets and Income Statements along with balance sheets and income statements for the various trusts. She also assists the Headquarters Manager with accounts analysis. Her job requires her to be in constant communication with all International Committees and Headquarters staff.

**INTERNATIONAL DIRECTORS** Directors are essential members of the International Board, working alongside officers to lead and strengthen our organization. They attend the annual meeting, the spring and the fall BOD meetings and represent the IBOD at assigned spring and fall Section meetings. They also serve as liaisons to international committees and contribute to special projects. This role is both a commitment and an opportunity to grow as a leader within The Ninety-Nines. Serving as a Director on the International Board of Directors is both an honor and an important responsibility. Directors play a role just as vital as that of the elected officers in guiding the organization forward. Directors are expected to become familiar with the functions of the BOD officers and the Headquarters staff.

**Note:** Serving as a member of the Board requires substantial time and constant communication with other members and with the membership in general. Each member of the Board must possess excellent communication skills and should have regular access to computer(s) and the internet.

Members of the International Board of Directors (President, Vice-President, Secretary, Treasurer and Directors) may submit 99s-related expenses for reimbursement per the Reimbursement Policy. The amount of the stipend is subject to change.

**THE NOMINATING COMMITTEE** members are responsible for presenting candidates for all elective positions. They need to know the requirements for each position and be able to communicate what will be expected of those volunteering. Committee members must be active at the Chapter and Section levels and identify individuals to serve at the international level. From resumes, letters of recommendation and personal contacts, the committee becomes custodian of very personal information about candidates.

It is the committee's responsibility to prepare and update suitable forms; supply copies of qualifications; provide photos and brief biographies of candidates and newly elected members and prepare other articles as appropriate to meet deadlines for the 99s magazine. Most importantly, the committee verifies that all candidates who submit an "Intent to Seek Election" form are qualified and meet the requirements specified in the Bylaws and Standing Rules prior to sending it on to the Board or the Election Procedures Chairman.
